Thank you for email and apologies for the delay in getting back to you.

Lorraine has looked into this and embarrassingly this is the second time in the last couple of months that between the three members of our team we have given conflicting advice relating to a planning application where Norfolk County Council is the determining authority.

This is due to the different ways we log and record planning cases or potential planning cases that do and don't require archaeological work, which we may well need to change.

Having looked at this I think it is a borderline case with at best moderate to low archaeological potential.

I am content to revert to our original advice.

Based on currently available information the above-mentioned application would not have any significant impacts on the Historic Environment in terms of below-ground archaeology.

No conditions for archaeological work will be required on application FUL/2023/0005.
