Breckland Council has considered the proposal and has NO OBJECTIONS

1. The Local Planning Authority wishes not to formally object to the planning application, subject to the inclusion of the following necessary mitigation measures:

Noise from the normal day to day operation of the proposed Aggregate and Soil Recovery Facility measured as an LAEQ (or equivalent continuous sound level) shall not exceed 10dBA over the background noise level measured as an LA90 (level exceeded 90% of the time) on the boundary with the nearest affected residential properties. The LA90 and LAEQ shall be measured using the principles contained in BS 4142:2014+A1:2019 and shall be measured over 1 hour during the applicants proposed operating hours. All measurements to be taken with a sound level meter of IEC 651 Type 1, or BS EN 61672 Class 1, standard (or the equivalent relevant UK adopted standard in force at the time of the measurements) set to measure using a fast time weighted response. This should be calibrated in accordance with the procedure specified in BS 4142:2014+A1:2019 (or the equivalent relevant UK adopted standard in force at the time of the measurements).

Reason for condition:- In the interest of the amenities of nearby residents in accordance with Breckland Local Plan (2019) Policy COM 03.

The operation of the proposed Aggregate and Soil Recovery Facility herby permitted shall not take place outside the hours of 07:30 - 16:30 Monday to Friday, nor at any time on Saturdays, Sundays, Bank Holidays or Public Holidays.

Reason for condition:- In the interest of the amenities of nearby residents in accordance with Breckland Local Plan (2019) Policy COM 03.

The proposed Aggregate and Soil Recovery Facility shall operate at all times in full compliance with the mitigation measures detailed within 5.9.1 - 5.9.7 of the submitted Noise Impact Assessment, ref No IEC/4470/01/AVH revision 02/F undertaken by Independent Environmental Consultancy Limited dated 22/03/2023.

Reason for condition:- In the interest of the amenities of nearby residents in accordance with Breckland Local Plan (2019) Policy COM 03.

Levels of NO2 and PM10 shall not exceed the levels detailed within the Air Quality Objectives Concentration in England at the nearby residential properties at any time.

The proposed Aggregate and Soil Recovery Facility shall operate at all times in full compliance with the mitigation measures detailed within table 6.2 and the monitoring measures detailed within 7.1 - 7.4 of the Dust Management Plan undertaken by Westbury Environmental ref 19/004h version 4 dated 24.03.2024 (sic) issue date 24.10.22
